**Eligibility** – Membership of the Credit Union is restricted only to employees and former employees of the Qantas Group of Companies and associated companies, the immediate family (partners, parents, children, brothers, sisters, grandparents, grandchildren, aunts and uncles) of existing Members and related organisations. I declare that I meet the eligibility requirements of the Credit Union.

**Financial Reports** – Every year the Credit Union produces reports that contain information about its financial position and performance, how efficiently it is being managed, and any financial risks it may face. The Credit Union is not required to send you a copy of the reports unless you elect to receive them. You can change your choice at any time by notifying the Credit Union in writing. The Credit Union will not send me its financial reports unless I ask them to. I can do this by telling the Credit Union now or sending a request in writing at any time.

**Tax File Number** – Collection of Tax File Number(s) is authorised, and its use and disclosure are strictly regulated by the tax laws and Privacy Act 1988. Quotation is not compulsory but tax may be taken out of your interest if you do not quote your Tax File Number, Australian Business Number or claim an exemption.
